TERMS AND CONDITIONS

What your program cost includes:

Review the program description enclosed with this enrolment form to be sure you know what's included in the 'Land Only' program cost, and what's not. Included are all events, activities, visits, cooking classes, tastings, guiding, transfers, hotel overnights with full breakfast, select lunches and dinners, as described in the 'day-by-day' description page. Not included are purely personal costs or expenses such as laundry, postage, phone calls, hotel bills or non-program beverages or other hotel services ordered. Airfare to the place where the program begins and ends within Asia, are not included.

Deposit and payment:

A non-refundable \$300 deposit is required at time of booking & upon confirmation in order to secure your reservation. Final payment is due 8 weeks before departure. Booking Deposits are used to secure accommodations at the time of booking, and as such are non-refundable. Deposits will be refunded, if you are not able to attend, should alternate participants join the tour to take up your place(s).

Passport: All passports must have a minimum of 6 months validity on them to obtain entry into Indonesia.

Costs not included in prices:

Passport, visas, insurance, excess baggage, extra meals (not specified as being included in itinerary), laundry, drinks, items of a personal nature or tips.

Pricing:

All prices are shown in Australian dollars and are current at date of printing this itinerary. If the exchange rate fluctuates dramatically, or if the price of services provided which are beyond the control of Crave Tours, then Crave Tours reserves the right to adjust tour prices accordingly, even though the balance of payment may have been made. This would only happen in very unusual circumstances.

Cancellation:

If cancelling prior to final payment the deposit is non-refundable. After final payment is received a cancellation fee of approximately 75% applies. This percentage may be less depending on the date of cancellation. A cancellation fee of 100% is applicable within 30 days of travel.
